The race is on!

Is Governor Ron DeSantis Trump 2.0 But With a Better Delivery?

March 9—Governor Ron DeSantis is getting national praise for his handling on the Chinese virus in Florida.

Even the awful *New York Times* is begrudgingly praising him. . . .

Gov. Ron DeSantis of Florida is a darling of the right-wing media, a staunch Trump conservative trying to position himself as the heir to the former president's political brand.

Gov. Andrew Cuomo of New York is a descendant of a liberal political dynasty, a Trump antagonist with his own, long-simmering presidential ambitions.

Both have been on the front lines of the government's response to the coronavirus pandemic. But recent twists in their political fortunes underscore how differently both parties are keeping score in this volatile moment.

Conservatives rewarded the governor for his fealty. His approval rating rose above water in recent weeks, with some polling of Republicans showing Mr. DeSantis with higher ratings than Mr. Trump.

He finished first in a straw poll at the Conservative Political Action Conference last weekend covering a field of

potential presidential candidates that did not include Mr. Trump, fueling chatter about a 2024 bid.

The Democrat Party has embraced a very different kind of political standard, one based not on allegiance to President Biden but ideological and cultural purity. Throughout the Trump era, Democrats equated politics with morality as a way to attack a Republican president who trafficked in racist and sexist attacks. They cast themselves as the party of #MeToo accountability, pressuring those in their ranks accused of sexual misconduct to step down.

That's left Democrats facing charges of hypocrisy when it comes to Mr. Cuomo, who is now accused of sexually harassing several younger women. While Mr. Cuomo has few defenders, many powerful New York Democrats, including Senators Chuck Schumer and Kirsten Gillibrand, are pushing for an independent investigation rather than an immediate resignation. The allegations have left his party divided between those who believe he must leave office and others who worry that the party is eating its own.

It doesn't help that before this current scandal, Mr. Cuomo was already under investigation for allegedly manipulating statistics on deaths of nursing home residents during the pandemic—chipping away at his image as a masterful manager of the virus and the Democratic brand of good governance. Once sailing toward a fourth term as governor, Mr. Cuomo is now fighting for his political career. His approval ratings have fallen nearly 30 points from last May.

Yet, for both men, their political fortunes and the tests imposed by their parties seem disconnected from the central question of this moment: Did they effectively govern their states through an extraordinarily challenging year?

When adjusted for population, Florida has a lower rate of deaths than New York, including at long-term care facilities like nursing homes.

Slightly more Floridians—8.7 percent of the population—than New Yorkers have received two doses of a Covid vaccine, but nearly the same percentage of the population in both states has received the first dose.

About a year into the pandemic, Mr. Cuomo has fallen from his perch as a liberal icon. Mr. DeSantis has ascended to conservative stardom.

Of course, priority number 1 for conservatives in Florida is to re-elect Mr. DeSantis as Governor in 2022 by a resounding margin.

Right now nothing else matters.

Election Integrity: Our Last Chance to Save the Republic

March 2—Chairwoman Ronna McDaniel Statement on *Brnovich v. DNC*:

WASHINGTON, DC—Today, Republican National Committee Chairwoman Ronna McDaniel released the following statement as the Supreme Court hears oral argument on a key voting integrity case, *Brnovich v. DNC*. In partnership with the Arizona Republican Party, the RNC and other party committees have been supporting this lawsuit as part of our ongoing commitment to restore election integrity and fight Democrat attempts to upend our elections processes.

“Democrats are trying to manipulate a key part of the Voting Rights Act, distorting a safeguard against legitimate discrimination into a blank check that would allow progressive judges to strike down nearly any election integrity measure they disagree with and legislate from the bench. It is critical that all voters have confidence in the integrity and legitimacy of our elections. The Supreme Court should reject Democrats’ attempts to weaponize the Voting Rights Act in the name of partisan politics.”

Background:

- In *Brnovich v. DNC*, Democrats are asking the Supreme Court to transform the plain language of Section 2 of the Voting Rights Act which forbids election laws that discrim-

inate on the basis of race, into a blank check that would allow for courts to strike down measures without limit.

- Using the Voting Rights Act as a tool to overturn race-neutral and minimally burdensome safeguards sets a dangerous precedent that further politicizes our courts and leaves states with fewer tools to administer safe and secure elections.
- The impetus behind this request are two commonsense, race-neutral Arizona laws: Arizona’s ban on ballot harvesting prevents bad actors with malicious intent from coercing or changing ballots, and its law requiring voters to vote in the correct precinct allows for the efficient administration of Arizona elections.
- The RNC is supporting the Arizona Republican Party with legal expertise and the resources to hire top-tier, specialist Supreme Court advocates.
- The RNC, NRCC and the NRSC have consistently worked with and supported the Arizona Republican Party in this important case since it was first filed in 2016.

February 28—Joe Biden, Nancy Pelosi, and Chuck Schumer are holding the American people hostage to pass a far-left wish list filled with a Jurassic amount of pork.

But their \$1.9 trillion wish list is not the first time Pelosi has put politics over the American people when it comes to the coronavirus:

- In April, Pelosi appeared on late night television to show off her expansive ice cream collection while delaying much needed PPP funding.
- In May, she openly touted using the coronavirus as an “opportunity” to pass far-left legislation.
- In August, she justified blocking bipartisan coronavirus relief for political reasons: “I don’t think strategically it’s where we should go.”
- In September, she broke California’s coronavirus guidelines to go to a salon and then demanded an apology from the salon owner.
- In October, she struggled to explain why she was not accepting Republican relief offers, and when pressed by CNN’s Wolf Blitzer, she sarcastically responded, “Thank you for your sensitivity to our constituents’ needs.”
- In December, after delaying relief for months, she admitted it was her “decision” to block a deal until after the election.
- And now, Pelosi is backing a hyper-partisan process to force through a far-left wish list so she can get funding for progressive pet projects, including \$112 million for transit in San Francisco.

The Democrats’ bill is not about the American people – it is a bloated progressive payoff where only 9% actually goes directly towards fighting the pandemic. It’s time for Democrats to stop the political games, and work with Republicans to reopen our schools and help the American people.

Biden's Cognitive Decline Becoming More Obvious

Less than one month ago—February 8th to be exact—I penned a commentary speculating on President Biden's ability to complete four years in office. I wondered if the Democrat leaders and the press had not conspired to conceal the extent of Biden's mental and physical disability as they did with President Roosevelt running for a fourth term. Those around FDR knew he would not survive much beyond his inauguration. He was a dead man walking throughout the campaign. He died three months into his fourth term.

The Covid-19 pandemic gave Biden and his aides the perfect cover. Throughout the campaign, Biden used the pandemic as the explanation for his staying in his basement bunker. He consented to very few one-on-one interviews with the friendliest of the fawning media sycophants.

Even with that limited exposure, there were a few senior moments that were described merely as gaffes or the residual of his youthful stuttering.

IN THAT EARLIER COMMENTARY, I CONCLUDED: "Unless he [Biden] is allowed to move out of his isolation bubble, we may not know the answers to all the questions regarding Biden's cognitive decline and health at this moment, but there is enough to be seen on the surface to warrant the questions and concerns."

Based on recent developments, we may be getting answers sooner than we expected. All the questions about Biden's cognitive function during the campaign were dismissed out-of-hand by the media—shaming individuals for even raising the question.

Since assuming the presidency, Biden has become even more insulated from public exposure. Trump tended to over-expose himself, with press engagements—formal and informal—on a daily basis. Biden, on the other hand, has made the White House his new Bunker.

He issues scripted video messages. He engages with world leaders and others through virtual meetings. These are relatively useless since world leaders are not about to engage in candid or classified conversations over the Internet.

She is doing the outside appearances, the round of press interviews and the meetings with high level officials. There are also whispers inside and outside of the White House that Chief of Staff Ron Klain is managing Biden on a day-to-day basis—and even making critical policy decisions.

Biden's personal appearances are rare, brief and orchestrated. He takes very few questions—and most of those are pre-screened. But even with such extremely limited exposure, Biden's "gaffes" have become more obvious and serious.

On two recent occasions, Biden's train-of-thought went off the tracks—and he stumbled and mumbled as he tried to find his point. He often has to pull notes out of his coat pocket to get back on track.

He could not recall the general number of Covid-19 deaths even though that 500,000 figure was easily recallable by virtually everyone talking about the issue.

Biden got as far as saying "five hundred. . .," but then stopped and could not recall the rest. He paused . . . then said he has a piece of paper. He pulled it out of his coat

pocket and stated the number of deaths. Then under his breath he questioned “Where am I?” That probably referred to his place in the speech. But it still showed some incapacity to pick up where he left off.

That was not the first time that Biden had a break in his train-of-thought and needed to pull a note from his pocket. More and more, Biden is showing that he cannot rely on his memory in ways that suggest some mental diminishment.

Let’s be perfectly clear. For the most part, Biden seems quite normal—but that is the nature of such age-related issues. It is just that they become more frequent and obvious as they become more serious. How bad Biden’s cognitive function is impossible to determine from a distance. He would have to take cognitive tests and submit to other diagnostic tools to know for sure.

He should at least undergo those diagnostic tests to either confirm his condition or to dispel the legitimate concerns. We can rest assured that he will not take such tests out of fear that they may prove he has a problem. Not submitting to such tests, however, will only reinforce the suspicions.

The obvious fact of Biden’s diminished schedule and public exposure—and the unprecedented use of surrogates in public appearances and for high-level meetings—will keep the issue alive.

His wife, aides, and the press may continue to protect Biden. Expressions of concern by Republicans and unbiased media can—and will—continue to be ignored. But

there is one group that will rat him out. The Democrats’ radical left.

It is a poorly held secret that the far-left extremists in the Democratic Party have been hoping and planning to have Biden ousted from the Oval Office so that Harris can move in. No one would like to see Biden become incapacitated more than people like Congresswoman Alexandria Ocasio-Cortez and the rest of the squad. They are already expressing opposition to Biden’s policies.

Make no mistake about it. Biden’s cognitive function is declining—and that will become more and more obvious month-after-month. It is one of the inevitabilities of old age—a condition that most Americans have seen in loved ones or even themselves.

I once gave Biden only a 50/50 chance of completing his full term. After seeing his most recent senior moments, I would reduce that to about a 30 percent chance.

Promoting Our Proud History

It never cease to amaze me how the Left continue to promote being the party of compassion, defenders of the disenfranchised and downtrodden, and the liberators of the oppressed, and shamelessly, while, at the same time, they continue to make false claims about their party's history. Knowingly, or unknowingly, their followers believed this faux history and ran with it. When their party declared that Republicans were racists, they ran with it. When their party said capitalism was nothing more than greed-inspired elites, and the wealthy, getting ahead on the backs of the poor, their voting bloc ran with it. Not satisfied with rewriting their own history, and erasing their nefarious past, they have taken pleasure in defining ours as the villain.

In the meantime, many Republican leaders on our side are sitting on our history and are mute about our party's historic accomplishments. For me, and other Black conservatives, this past February, nationally known as Black History Month, was a great opportunity for our side of the aisle to sing the praises of God Almighty, and the 1860s Republicans, who stood up and made the difference when this nation found itself at the crossroad of slavery and freedom for Blacks in America. Yet, I cannot remember a single United States Republican Senator or Republican Representative address a national audience about the accomplishments of our party, namely the party of Lincoln and freedom.

They could have talked about Blacks who became Congressmen at both the state and national levels starting in 1870, thanks to the tireless efforts of the Republican Party and the bills they passed when in power. They could have noted that from 1870 thru 1935, every Black statesman in this country was a Republican. They could have even talked about former born-into-slavery, turned activist and millionaire, Frederick Douglass. His is an inspiring story to tell. We can also add Booker T. Washington, Harriet Tubman, and many others, who were Black Republicans in those days. Our leaders, if they wanted to shy away from mentioning Blacks, they could have talked about the 1860s Radical Republicans, who were featured in the critically acclaimed, Academy Award winning film, *Lincoln*, which was surprisingly directed by a hardcore liberal, Steven Spielberg. These 1860s Radical Republicans were strong advocates, defiant, and determined voices and proponents of Black citizenship, property ownership, and the crown jewel of them all—Black voting rights. And the majority of them were White Americans.

They could have talked about our support for women's suffrage (voting rights) and how we made it a campaign issue for Democrat President Woodrow Wilson, a known racist, who saw that it was futile for him to continue to oppose rights for women. In the end, he capitulated and passed the bill that benefited the women's rights movement.



Although Wilson was opposed to women having these rights, he gets the credit for signing the bill into law. Shamelessly, liberals have used this signing as a way to promote their so-called long history of support for women. In the meantime, the party that came into existence for the sole purpose of ending slavery, who passed the 13th, 14th, and 15th Amendment and who were the true champions of women's rights, as well as the legislators who authored every civil rights bill going back to 1866, are rarely mentioned during Black History Month, nor are their accomplishments ever espoused by our leadership when they are in the national spotlight. Mum is the word, it seems.

Frankly, this is a problem we must take our leaders to task with. We are the party who, despite some of our failings, continues to support the core principles this republic was founded on. We are the party that laid the foundation for the rise of Black politicians, bankers, lawyers, engineers and doctors, during Reconstruction. And for all of the bad-mouthing the Left has done, and the lies they have spewed against us, our leaders seem uninspired and uninterested in taking these lying liberals to task and putting both party's history in perspective, as far as civil rights is concerned. It was White Radical Republican blood that was spilled, and White Radical Republican men who were lynched alongside of blacks, not Democrats, and all because of their moral, religious, and conservative support for the rights and freedoms of Blacks in America.

While Republicans were rescuing Blacks and helping them to escape the bondage of slavery, southern Democrats were oppressing, torturing and killing Blacks, and their supporters, every inch of the way. 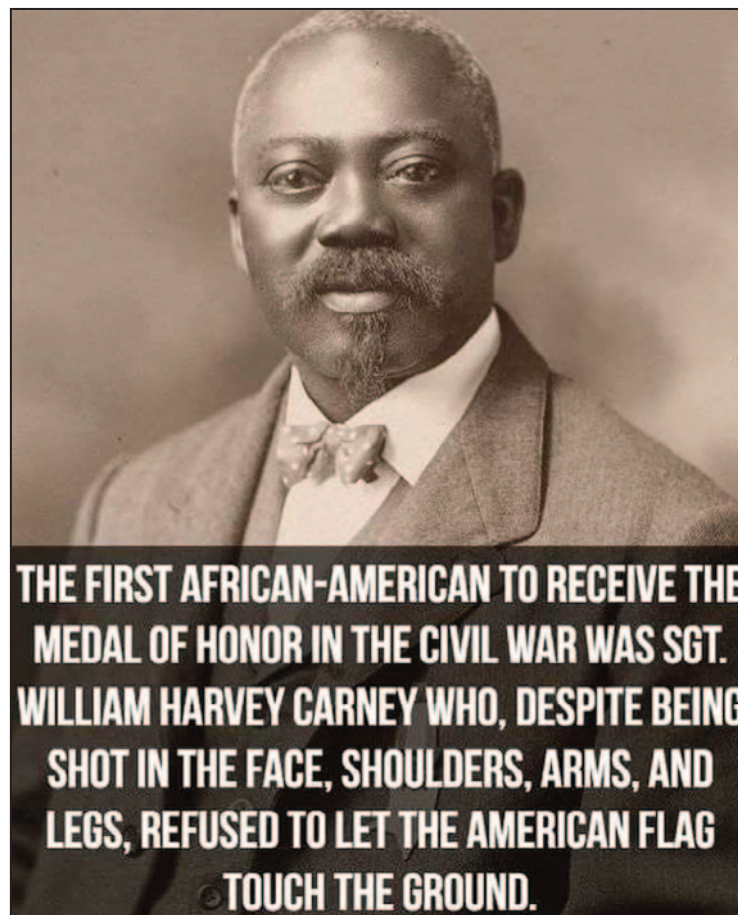
There was once a powerful man, who identified as a Republican, who stood up for liberty and the U.S. Consti-

BLACK LIVES MATTER. . . !!!

. . . As do yellow, red, white, and brown! Why then does the emphasis play a big part only in the black color range? Clearly, the emphasis upon Blacks is based upon a prejudice inherent in most journalists. Those who write columns with this emphasis do so with a prejudicial focus. It is bad journalism, bad writing, and poor distribution of supposed facts.

The information distributed in such writings is wrong (either accidentally or intentionally). I reject the idea that based on numbers alone that most of these are accidental. Simple 101 journalism makes it clear to everybody entering the field that whatever news stories one writes should be based on facts (not opinion). However, Simple 101 is no longer simple nor journalism. It is instead a contortion of the writer's opinion. It ignores facts and truth. It is a twisting of language to fit the situation the writer would like to see exist rather than reflect as honestly presented.

Here, in my opinion, is what makes a simple and unchallengeable premise into a challenging attack. If you cannot show the nation that the matter in which we deal with the Black population is the most honest, proud, and defensible compared with anywhere else in the world, we have lost the battle. In essence we have lost not the truth alone, but all of the praise such a way of life would accrue to us. We allow lies to dominate our negative media, our politics, and our educational facilities. Everyone is taught that our conduct is pro-White and anti-Black by all communicative facilities. This is the actual opposite of truth.

If we accumulate the data on White vs. Black, criticism of White in 90% percent of the media shows a left-wing bias. On the other hand, a compilation of media entries favoring Whites shows the exact opposite: biased media inputs so overwhelm the left by the right that it is incomprehensible that it should even be deemed "journalism."

Yes, Black lives matter, but so do the lives of all other racial groups. One may find detailed media coverage of every Black hurt or killed on a daily basis. However, the number of deaths and injuries properly attributed to non-Blacks by Blacks is scarce to say the least. Why? In my opinion, the problem is most prevalent among so-called Black families. About 75 percent of Black families have no grown-up Black examples as to how one how decent people should conduct themselves.

Therefore, roaming the streets unsupervised leaves so many more trouble makers within the Black community as



opposed to others. The result is generations of Blacks are bearing fatherless children, stealing cars, using and selling drugs, destroying private property, and mutilating public property, etc.—all in the name of so-called social justice. For the People Act of 2021—NOT!

Many, if not most, acts of Congress are misnamed to give the impression that it is going to be good for the country. This one is a flat out lie—unless “the people” it references is limited to Democratic candidates for office who espouse authoritarian government. This is the result of many years of effort by the Democratic Party and their allied groups to wipeout all the safeguards in election rules. The Heritage Foundation summarized the bill as an attempt to “federalize and micromanage the election process administered by the states, imposing unnecessary, unwise, and unconstitutional mandates on the states and reversing the decentralization of the American election process, which is essential to the protection of our liberty.”

Let’s look at some specific provisions of the section on election laws. *The Epoch Times* (March 10–18) listed 30 key changes how this new law will change elections in favor of the political party that, by hook or by crook, won the election Nov. 3, 2020.

First the good rules changes: ensuring that all voting machines used in U.S. elections are manufactured in the United States and easier access for voters with disabilities. That’s it.

Here are some on of the worst provisions in the “election reform package.”

- Gives the federal government authority to administer elections—even though the Constitution gives states that authority in Article I, Section 4. This law requires federal government approval for any state rule changes overriding the constitutional guarantee that state legislatures, not the federal government, will establish election practices.
- Mandates automatic voter registration in all 50 states with same day and online registration. Bans state voter ID laws. Personal ID verification is required for so many reasons like cashing a check, flying on an airline—or to attend a Democratic convention—it is deemed to be an unnecessary requirement in exercising a constitutional right to vote for your representatives. There’s only one main reason for not wanting photo ID to vote.
- Mandates no-fault absentee ballots and does away with witness signature or notarization and forces states to accept ballot up to 10 days after the election date.
- The new law prevents election officials from removing ineligible voters or confirming eligibility of voters registered in multiple states.
- States are required to permit same-day registration, including for early voting, at polling stations. The section includes a clause that requires same-day voter registration to be implemented in time for the upcoming elections in 2022.
- Limits plaintiff’s access to federal courts when challenging the Act with several restrictions.

- Forms new commissions. One of them is a commission to “protect United States democratic institutions.” It would comprise 10 members, only four to be selected by the minority party. The Dems must believe they will maintain majority party status which this Act will surely help them achieve.
- Promotes ballot harvesting, another easy way to cheat. Any designated, but not paid, person can return no limit of absentee ballots to any drop-off location or election office.
- Allows felons to vote. Allows politicians (themselves) to use campaign funds for personal use. Mandates early voting.
- Allows 16-year-olds to register to vote: From Jan. 1, 2022, states wouldn’t be allowed to refuse a voting application from anyone aged 16 or older. Additionally, states would be required “to carry out a plan to increase the involvement of individuals under 18 years of age in public election activities.”
- Requires colleges and universities to hire “campus vote coordinators”: The bill requires institutions of higher learning to employ an official who would be responsible for informing students about elections and encouraging them to register to vote. It would incentivize voter registration by giving grants to institutions that have a high registration rate.
- Requires states to allow curbside voting: States may not “prohibit any jurisdiction administering an election for Federal office in the State from utilizing curbside voting as a method by which individuals may cast ballots in the election.”
- The bill provides for states to establish independent, non-partisan redistricting commissions taking power away from state legislatures.



The House passed H.R. 1 on a near party-line vote of 220–210 on March 3. As S. 1 it will now head to the Senate, which is split 50–50 between Democrats and Republicans. With Kamala Harris holding the tie-breaking vote, it is expected the bill will pass unless Republicans successfully employ the filibuster.

If it passes, it will a long, long time before another Republican is elected president.

Book Review

***A Republic Under Assault: The Left’s Ongoing Attack On American Freedom*, by Tom Fitton of Judicial Watch, Threshold Editions, Simon & Schuster, Inc., 2020, 312 pp., including acknowledgements, appendices and notes, ISBN: 978-1-9821-6365-5**

This is the second report of Judicial Watch’s ongoing lawsuits enforcing the Federal Freedom of Information Act (FOIA) the organization uses to discover activities of the Deep State and various Washington, D.C. swamp creatures. The contents of the book are the results of many hours of letters requesting information that the law allows interested citizens to learn what the government is doing.

Judicial Watch research results are used to make known what government agencies are doing so that we can learn what the government agencies and their political bosses are implementing and managing laws passed by the Congress. The book contains six major sections, namely: Section One—Our Republic Under Assault . . . from the Deep State, 104 pages; Section Two—Our Republic Under Assault . . . from the Impeachment Coup Attack on President Trump, 24 pages; Section Three—Our Republic (Still) Under Assault . . . from Hillary Clinton, 84 pages; Section Four—Our Republic Under Assault . . . at the Ballot Box, 40 pages; Section Five—Our Republic Under Assault . . . at Our Border, 20 pages; and Section Six—How to Protect and Save Our Republic, 8 pages.

Unfortunately, just reading Section Six does not give the reader a full picture of the tasks necessary to fulfill the promise of Section Six’s title. Fitton calls for all of us to be involved in these tasks or the Left will win. Fitton quotes Ronald Reagan’s Farewell Address of January 11, 1989 wherein he said we must more strongly protect the freedoms of speech, religion and enterprise. We must “re-institutionalize these freedoms,” asking the questions, “If not us who? And if not now, when?”

In Section One, Fitton sets the stage by telling about the founding of Judicial Watch in 1994 to governments and other institutions accountable to the Rule of Law. When the agencies of government start going off the expected course, Judicial Watch notices and starts asking questions by using the Freedom of Information Act to get documentation to get the

courts to stop improper behavior. So when Obama-Clinton/CIA/FBI/DNC Obamagate/ Spy Gate began in 2016 or before, JW started asking for documents.

It is important to keep in mind the statute limits what can be requested and the Deep State actors may make it difficult to get copies of documents. Section One is mostly discovery done during the Crossfire Hurricane stage of the investigative activity.

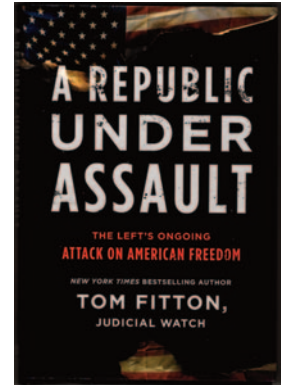
Section Two provides more details of the impeachment-coup attack against Donald Trump by California Representative Adam Schiff and his conspirators. 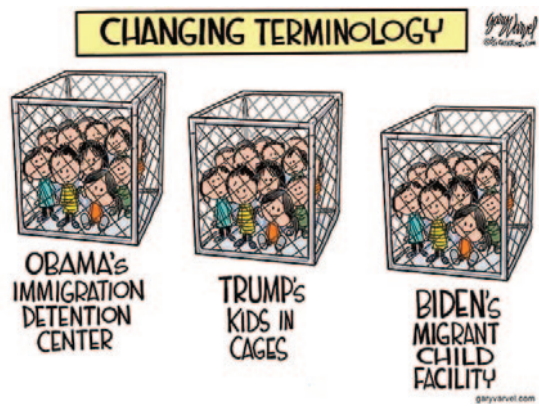

Mark Levin’s Interview with Florida Governor Ron DeSantis, February 28

Mark Levin interviewed Florida’s Governor Ron DeSantis for the full hour on his show, “Life, Liberty and Levin,” on the Fox News Channel on February 28, 2021. What follows is a partial transcript of the interview.

LEVIN: One of the most prosperous and successful states in the Union is Florida. It’s also the third most populous state and the numbers are growing every day. People are leaving blue states . . . and they’re heading to Florida. They like the government there, they like the leadership of the governor, they like the weather, they like that there are no income taxes.

LEVIN: The liberal media doesn’t like you so I want to give you an opportunity to cover a number of areas because you’ve been enormously successful. First, the virus. What have you done to protect your population.

DeSANTIS: Well, we looked at the data we had and we saw that this was a virus that had a disproportionate impact on elderly people and we’re the second oldest state in the country, so we viewed it as something taking action to protect those vulnerable people as best we could. So one of the things we did, before any other state, was protect nursing homes. We barred hospitals from sending [covid patients] into nursing homes. [As a result] although we are among the most populous states, we are 27th in terms of death rates from the disease.



LEVIN: What is your take on how the Trump Administration handled this?

DeSANTIS: In terms of the vaccines and the testing the logistics was really good. It was a very difficult operation and Warp Speed got it done. With the testing, it allowed us to leverage testing in ways that made sense to save lives. I wasn’t ever a believer that every healthy person walking down the street needs to get tested. It’s just not the way the medical science usually works. But what I did say was that we have nursing home staff, we having nursing home residents, we have other elderly people, so let’s focus the testing on those. So what we ended up doing was establishing

covid-only facilities so that if you had a positive test result in a nursing home and you weren’t able to isolate that resident, we had a place where you could safely transfer them where they could recover and not endanger other folks. But having the testing to be able to identify those folks offered an additional coat of protection so we wouldn’t have been able to do that without the federal government pushing those resources down to the state of Florida.



LEVIN: And how have you handled the distribution of vaccines?

DeSANTIS: We were very simple, Mark—seniors first, and that was against the CDC recommendations. The CDC initially didn’t want to put seniors in front of the line at all. They wanted to do young workers, which would have had a 20-year-old grocery store clerk get a vaccine before a 74-year-old grandmother and that did not make any sense in terms of where the risk is on this. So, I was the first governor in the country to reject those guidelines and I said we are going to do our 65 and up community. I think that those states that prioritized the elderly for vaccinations, when the dust settles on this in a couple of months, were able to reduce mortality, unlike other states that did not. Some states vaccinated their prisoners before they did the elderly! It’s crazy. I didn’t want politics to be in this. I wanted to focus where the risk was. And what’s happened since then is that other states started following Florida and even the CDC had to say, no, you do need to do 65 and up. We were right on that because we had a firm grasp on the data, understood where the risk was and we were going to make sure that we were applying those resources that would save the most lives.

LEVIN: Give us a little bit on your background.

DeSANTIS: I'm a native Floridian who grew up playing baseball, a public-school kid, ended up being recruited to play at Yale University, and I had never been to New England in my life, so I showed up the first day of school with jean shorts and a t-shirt on, which was pretty standard for where I grew up in Florida, but was not well received in New England at a place like Yale. I played baseball there for four years, eventually went to Harvard Law School and was commissioned in the Navy as an officer with Navy JAG. I served stateside, I served in Iraq, and was a federal prosecutor for a time. And then I got elected to the Congress in 2012 and then elected governor in 2018. But I think that what some of those experiences have showed me is the role that leadership plays in politics. You and I may interview conservative candidates and they may do the conservative check-list, they may say all the right things, but the question is, when you get into a position in the Congress or the governorship and the klieg lights are on and the pressure is on, are you going to have the backbone to stand up and do what's right? And I think that I was prepared to do that.

Obviously when I got elected no one was thinking that we would have a global pandemic, but I think that throughout this I've always had the courage of my convictions to do what's right, to stand up for folks that no one was necessarily talking about, like people that work in restaurants, or parents that want their kids in in-person schools, or the small business folks who've had their world turned upside down. I made sure to look out for them every step of the way and I think Florida's been better for it.

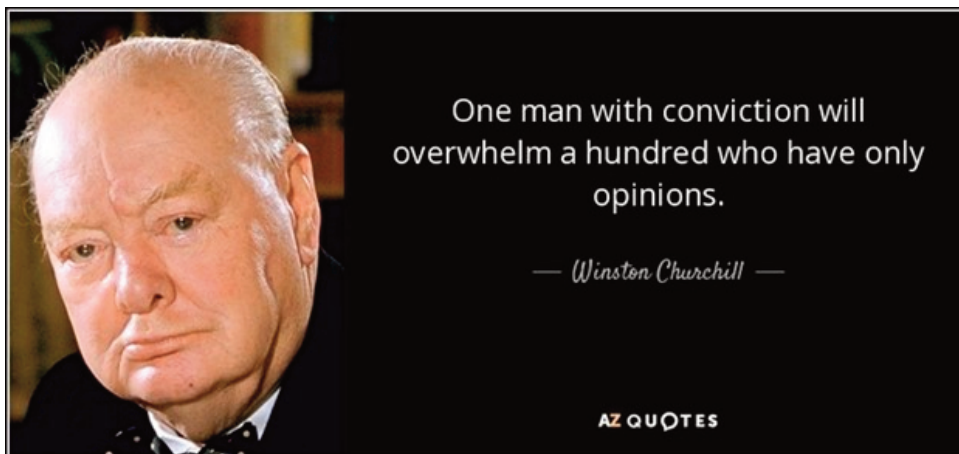
LEVIN: I want to ask you about your schools. I live in the state of Virginia, which is really a state of confusion and teacher's union control even though we're a right to work state. We have a Democrat Governor, Democrat Lt. Governor, Democrat Attorney General, a Democrat Assembly, a Democrat Senate, and they abide by what the teacher's union tell them. Last year in my county the teachers got a

7% salary increase and the schools weren't open, and I want to ask you, in Florida are the schools open? Is there an option for kids to physically go to school to be educated?

DeSANTIS: In Florida, every parent has the right to send their kid to in-person instruction and that's the typical school districts, the public schools, our charter schools and out private schools. Now we give the parent the option to opt for virtual, but fewer of them are opting for that everyday, and I think that this a really seminal issue of this whole thing—where did you come down on the schools, because you hear people on the left always say that they “believe in science” and yet these are the same people who are fighting to keep schools closed. There is no scientific evidence or data to suggest that schools should be closed. So we were one of the first over the summer saying we're getting the kids back and I can tell you it's been a huge success and think that if parents didn't have that opportunity you would have see more and more students fall behind every day, and we were able to announce just this week that we're now number two in AP scores in the country out of the 50 states.

But the one thing that we looked at on this data when we looked at Europe and countries that'd had kids in school was that there were not significant outbreaks from kids being in school. For whatever reason, kids weren't big spreaders of it, so there is literally no reason why schools should be closed. As you've said, this is politics. This is Democrats honoring a special interest, a union over the well-being of parents and families. And I look at some of these places where the schools have been locked down, the kids will be out of school for 1½ years and the number of people who are going to fall by the wayside because of those bad policies are going to be astronomical, and the problems from this are going to last potentially for a generation.

Tom Mullings is a decorated Army infantry combat veteran of the Vietnam War, who served as a scout dog handler with the 173rd Airborne Brigade. The role of committeeman or committeewoman is essential to Republican Party's and our candidates' success in Palm Beach County.
