The Perjury Trap for a Great American Soldier and Patriot

There is a great deal of discussion in the media these days about perjury traps, yet the public is woefully unaware what a perjury trap is. Simply stated, a perjury trap is a technique used by the Federal Bureau of Investigation to try to catch the subject of an interrogation in a "lie." Occasionally the lie is of their (the FBI's) own fabrication. To spring the trap, the FBI will gather information and evidence concerning the activities of an individual that they are targeting relative to some crime or suspected crime. To do so, they must have "opened" a case file on that individual. The information or evidence gathered may take the form of physical evidence, electronic intercepts (wiretaps or electronic eavesdropping), videos, transcripts, intercepts and/or interviews with other individuals. Having analyzed the "evidence" gathered by them, they will then interview the target and take a

statement. That statement as given is closely reviewed for any evidence of evasion on the part of the target being interviewed, as well as inconsistencies with other evidence previously gathered elsewhere. If there are any outright, deliberate, intentional lies, or *material* inconsistencies detected, the FBI may bring charges. "Is there anything that we (the FBI) can use to squeeze the targeted individual?" It is illegal to lie to the FBI, just ask Martha Stuart. It's not illegal for them to lie to you.

Of course, the questioning of a target takes place subsequent to the events

being investigated, perhaps long after. That individual's memory may not be perfect, as recollections often fade over time. The reality here is that many of the individuals questioned are guilty as hell and lie through their teeth, but many are not! Lapses of memory may produce inconsistencies.

Often, the FBI plays fast and loose. "Let's see if we can get him/her to lie." That really happens. Many times, they manipulate the evidence with the express intent to trick the target into making an incorrect statement due to faulty recollections, with the express intent of bringing criminal

charges when they detect that "lie." That's ultimately what they did in 2017 to U.S. Army Lieutenant General (LTG) Michael T. Flynn, a three-star general with 33 years of active duty service around the globe

Let's examine the reasons why the FBI decided to investigate LTG Flynn. LTG Flynn, a serving Army Flag Officer, was the Director of the Defense Intelligence Agency (DIA) in the Obama Administration from 2012 to 2014. As DIA he oversaw all military intelligence agencies. LTG Flynn was of the opinion, a well-informed one, that the Obama Administration's "Legacy" nuclear deal with Iran was a dangerous mistake. One that would ultimately lead to Iran possessing nuclear weapons in the not-too-distant future (and where Iran was given billions of dollars in hard currency to boot). He advised against it. He also believed that President Obama was

wrong about Al-Qaeda being close to defeat, and gave testimony to that effect to Congress. This contradicted Obama's representations to the contrary. LTG Flynn pointed out to Congress that Al-Qaeda had established itself across northern Africa and was training recruits in the Middle East. He also disagreed with the President's approach to problems with Syria. LTG Flynn's positions back then represented an existential threat to Obama's legacy and to the deep state. Remember: The Iran nuclear deal as Obama's Legacy piece. His shining star in the history books.

Around this time, Stephan Halper, the same character that the FBI later engaged to spy on Carter Page, invites LTG Flynn, then the DIA Chief, to a conference at Cambridge University in England. During a dinner at which LTG Flynn was the guest of honor, he is seated next to Svetlana Lokhova, a Russian woman living in England. In a ham-fisted effort to discredit LTG Flynn, "Someone" leaked a malicious rumor that she was a Russian "honeytrap"

directed at LTG Flynn. Undoubtedly, a setup by Halper, but for whom? Obama ultimately tired of the intrigue and just fired LTG Flynn in 2014, thereby forcing him into retirement from the Army. There it was, "problem solved, threat neutralized." Whew, we can all relax now, folks!

Not so fast! Michael Flynn the civilian becomes involved in the presidential candidacy of Donald J. Trump. After Donald Trump became President-Elect in November 2016, he designated Michael Flynn to be his Director of National Intelligence (DNI). Because of that, Michael Flynn now became an exponentially more dangerous threat to the deep state because Mr. Flynn wanted to clean house at the various bloated intelligence agencies he would oversee, and rid them of the political bias that he believed pervaded them. As the incoming DNI, he would be in a position to do just that. The deep state now had serious problems here—Michael Flynn and Donald Trump. They were determined to get rid of both of them! The response to Donald Trump was the Mueller Investigation which, when it came up empty handed on Russian collusion, tried to set its own perjury trap for President Trump by demanding to question him about "his obstruction of justice." They failed miserably when the President didn't take the bait.

The FBI was not discouraged that they had no case against Mike Flynn. Now, the FBI investigates crimes not political polls. To open an investigation, they must have probable cause, and enter the specifics in an electronic document, stating the nature of the crime and the evidence they possessed. The original file previously opened on Mike Flynn was based on the fact that "He knew the President; had visited Russia; and knew some Russians." That was it! That's all they had— NOTHING. If that was evidence of wrongdoing the Clintons would be in prison, and the Clinton Foundation would be today's Enron scandal! Based on what they had, if they took their existing "case" to court they would have been laughed out. Nonetheless, a plot was hatched to take Flynn down as part of the campaign to destroy Donald Trump's presidency. Mike Flynn, as part of the Trump Transition Team, held a telephone conversation with the Russian Ambassador to the U.S. That is neither illegal nor unusual. If Obama's transition team hadn't done the same in 2008, they would have been shirking their responsibilities. Comey directed his FBI cronies to seize on this call as a tool to get Mike Flynn. They continued their investigation.

After their initial investigation of Mike Flynn, the FBI had determined that there was no detrimental evidence found at all, and the FBI was in the process of closing out the file. Peter Strzok, Comey's point man on various investigations, heard on January 4th that it is to be closed and arranges for it to remain open. Bells must have been rung that night because the next day, on January 5, 2017, as an Oval Office meeting was breaking up, President Obama asked Sally Yates, Jim Comey, Susan Rice, and VP Joe Biden to stay behind. He then went on to discuss the Russia

collusion investigation and the Mike Flynn investigation. He said he was aware of the Flynn investigation but didn't want any more information on it. He asked the assembled participants "how the White House should now treat Mike Flynn." Really. On January 5th, the inauguration of Donald Trump was only 15 days away. How to treat Mike Flynn over the next 14½ days!

Sally Yates, the then Acting Attorney General, was astounded. Astounded that there was an investigation of a political campaign at all, that she had no knowledge of that investigation, and that Obama did. Something was up! She had not been read in on the Mike Flynn investigation by Jim Comey, her subordinate at the FBI. She does recalls that Comes discussed something about using the Logan Act against Mike Flynn but can't recall the details. Welcome to the Oval Office! So much for Obama not knowing anything. As for Joe Biden, it's anybody's guess what he knew or remembers.

"How should we treat him?" Just what action had Obama contemplated concerning Mike Flynn over the remaining 14½ days of the Obama presidency? Subsequent to that meeting, on January 20th, Susan Rice, as she was about to leave her post in the Obama Administration—literally as she was walking out the door as Donald Trump was being sworn in—wrote an e-mail to herself into the official file that claims that during that January 5th meeting in the Oval Office, President Obama said that "everything must be done by the book." What everything? Just what had they been contemplating for the remaining 14½ days of his presidency, and why was it so important to Rice that she memorialize Obama's "comments" then? Had they done something? Had they set something up?

Absolutely they had! The "something" transpired shortly after the inauguration. Comey tried to ambush Mike Flynn by sending two FBI agents to the White House to "talk to him "about his discussion with the Russian ambassador. This was to be in furtherance of the "investigation." But there was not only no predicate for the investigation itself, there was also no predicate for that interview. Normally, an interview with the individual is to obtain information that is missing from the file. In the case of Mike Flynn, the information in its entirety was the phone call itself, and the FBI already had a complete copy of the transcript. They had obtained it when they routinely wiretapped the Russian ambassador when he spoke to Mike Flynn on the phone. There was nothing to be gained from interviewing Mike Flynn, thus no predicate. The tapping of telephone conversations of foreigners is legal; the tapping of the Russians is routine. Both Mike Flynn and the Russian knew that they were being recorded. What was illegal, though, was that someone "unmasked" Mike Flynn and leaked a transcript of the entire call to their allies in the press in furtherance of the Democrat "Russia Conspiracy" hoax. Those actions unmasking and leaking—are felonies.

Nonetheless, the meeting was conducted and the two agents reported back to the Hoover Building. They reported that they thought Mike Flynn had answered truthfully and that he showed no signs of deception. They so stated that in their 302 forms, which is/are the official FBI forms used to summarize the agent's report of the meeting. The ambush had failed! Yeah, Mike Flynn is cleared once again. The FBI has concluded that he didn't lie.

This was not to be. Those original 302's, along with the agents' handwritten notes on the meeting, "disappear" from the official FBI files and the 302's were replaced with an altered copy/copies (two or more altered forms). Those phony, concocted documents, along with others, were used to bring criminal charges against Mike Flynn for "lying" to the FBI. The FBI prosecuted the case in such a way that Flynn's attorneys were constantly running up billable hours responding to the FBI lawyers. This is a typical FBI technique to wear down a "target." With legal bills running to about \$6 million, and after being forced to sell his house to keep up with them, Mike Flynn was bankrupt. He had no more money. The FBI harangued him about pleading guilty, even suggesting that there could be a suspended sentence. Mike still would not plead out.

After leaving the Army, Mike Flynn lobbied for a Turkish company. Unbeknownst to Flynn, that firm was owned by the Turkish government. The FBI seized on this and claimed that Flynn was guilty of not registering as an agent of a foreign government. Usually that is no big deal. The individual just registers and pays a fine. In a recent case against Clinton friend Tony Podesta, similar charges arising out of the Mueller investigation were simply dropped without prosecution.

Not here. The FBI threatened to not only charge Mike Flynn, but his son as well. His son had been involved in the business. Would the FBI have charged Mike's son? Well, yes, they would! This was the same group of FBI prosecutors who altered the original 301's and used them to charge Mike himself. Having been driven to bankruptcy by the FBI, and to protect his son from prosecution and potential imprisonment, Mike Flynn plead guilty to two charges. The deep state and their despicable allies in the lame stream media are overjoyed. Look, Flynn is guilty! But their joy was premature.

Mike Flynn had fired his previous law firm, the one in which Obama's former Attorney General, Eric Holder, is a partner. Believing in Mike's innocence, his new attorney, Sidney Powell, moved to have his guilty plea withdrawn and moved for the FBI and Mike's former law firm to produce more documents. Concurrent with that, Attorney Gen-

eral Bill Barr appointed a U.S. Attorney from Missouri to review the whole Flynn case. The results are astounding.

The former law firm produced thousands and thousands more documents they had "overlooked" in the previous production of documents. But the most important revelations come from the FBI files. Among other documents produced by the FBI, after years of stonewalling, is a handwritten note by an FBI official asking about the Flynn interview. "What do we want, the truth? Or do we want to force him to lie so we can get him fired or prosecute him."

There were also emails from former FBI agent Peter Strzok and his lover the former FBI lawyer Lisa Page talking about how they had altered the original FBI 302 forms (which still remain missing), the ones saying that Mike Flynn had *not* lied. They were altered in such a way as to appear that he had lied, and were submitted to the Court as evidence. The phony, concocted FBI evidence used against Mike Flynn was so damning they had the judge asking the FBI if they wanted to charge him with treason, a capital offense.

All this exculpatory material, the fabricated FBI lies and forgeries, were now brought into the light by Sidney Powell, Flynn's new attorney, and by that federal prosecutor from Missouri appointed by Bill Barr. Once those ugly, true facts were unearthed, AG Barr moved to have all charges against Mike Flynn withdrawn.

Let's see what Judge Sullivan, the trial judge does now. He may agree to close the case outright, or he may decide to hold a hearing to see just who did what to Mike Flynn. If he has a hearing, woe be to the conspirators! That process would embarrass the hell out of the Justice Department, but so be it. I hope he does just that. More to come. More documents are on the way to Flynn's new lawyer. This is not even close to being over

Mike Flynn was set up! Framed by the FBI! Not by a perjury trap, that failed. But when that failed, by altering documents and inventing evidence to submit to the court. There you have it. American justice?

No! It was the deep state! An Obama-Brennan-Clapper-Comey-McCabe-Strzok-Page cabal that framed an innocent man just because his policies differed from theirs, and just because they could. Looking at the history of his statements, I wouldn't believe one thing this guy says.



January 14: PRC National Health Commission chief Ma Xiaowei privately warns colleagues the virus is likely to develop into a major public health event.

Who Will Republicans Choose to Challenge Rep. Lois Frankel?

As the August 18 primary approaches, the field of Republican candidates to replace Rep. Lois Frankel in Congressional District 21 has narrowed. The Republicans that qualified for the ballot are Liz Felton, Mike Vilardi, Christian Acosta, Laura Loomer, Aaron Scanlan and Reba Sherrill.

As in previous issues, we asked all the candidates for their views for primary voters to weigh and contrast. This month we asked that the candidates to share their more immediate goal as a new representative or, if they prefer, "why should GOP voters choose you over your competitors in the August primary?"

Do the Dems Have a God Problem?

Political campaigns bring out the best and the worst in some people. Listeners make up their minds about political promises based on their own understanding of what the candidates are saying during the political campaigns. Listeners evaluate whether what is said based on their own experiences and learning, including their own religion. Whether a politician's promise is "good" or "bad" will be at least partly dependent upon what the listener's beliefs are at the time the promises are made known.

The First Amendment says, "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances." The part of this amendment that deals with religion contains the "establishment clause" and the "free exercise" clause. This clearly says government cannot make laws that affect religion.

In 2012, the Democratic Party had a debate and a vote at the Democratic National Convention in Philadelphia about putting God back in their national platform, and a sizeable part of the hundreds of delegates booed the result. In the 2016 platform, "God" was named in "God-given potential" in the preamble and by inference in the section on LBTG people. It is not clear how many times the Democrat delegates booed at which provisions in 2016

Democrat candidates for President in 2020 have expressed views that present religious questions. We as individuals or voters cannot stop them from having these views, but we can ask them to clarify those views and take those views into our own account when deciding whether we want to support or vote for a candidate for office.

In an article titled, "Democrats still haven't faced their God problem," by Salena Zito on March 15, 2017 in the *New York Post*, the author writes,

"The Democratic Party has a God problem. And over the last couple of decades, as its base became more educated, less religious and more urban, this problem has only grown.

"Some of this has to do with lower church attendance in cities versus rural areas, and the Democratic Party's increasing reliance on urban voters. Some of it is the divisiveness of social or cultural issues like abortion and gay marriage. And the divide has seemingly sapped Democrats' ability to communicate to religious Americans."

Especially if those people of faith are white, according to Brad Chism, a longtime and respected Democratic strategist based in Mississippi.

"And that problem extends to the national media, who by and large are mostly Democrats, meaning you have these powerful forces who do not understand more than half of the people in this country," he said.

Chism makes a crucial point about what this means for American politics: Some of the greatest moral advancements in our country's history have been accomplished largely through the influence of the



church and churchgoing people, especially through the 20th century.

"You look at women's suffrage, civil rights, the abolition of slavery and all of these massive other changes—religion and religious people have played a role in moving society toward a higher plane," said Chism.

"We've seen that recently as well, but a lot of progressives and liberal Democrats don't see the role of religion in society, and that is a big mistake," he said.

Return Trump to the Fight





Our Food Give Away Moves On

MAY 8—All I can say is . . . Thank you! Thank you! Thank you!!

The many, many responses that I received from the message I sent out recently about a proposed Republican Food Give Away lets me know that we are "on fire" and ready to move on, both politically and as humanitarians, to get enough GOP votes in Broward County to give Donald Trump the necessary 29 electoral votes from Florida to help him win a much deserved second term in the White House.

So, let me give you an update on where we are, and what we will still need to do to continue moving forward.

- 1) We Have a Date and Time: In conversation with Rev. O'Neal Dozier we concluded that Saturday, May 30th will give us enough time to get the word out, and to organize properly to get the food to those who need it the most. On May 30th, the time for us to pass out food, and deliver it, to people has been estimated at 9 a.m. to 1 p.m. Other pertinent information will follow below.
- 2) *Locations:* It was decided that three locations in Broward County, including one each in North, Central, and the South parts of the county, would be adequate to service the population we are trying to reach. For the North, we have locked down Rev. Dozier's Worldwide Christian Center church in Pompano Beach for a drop off, pick up, and possible delivery. So, we are in need of food drop off locations for people to come and get food, and also for us to deliver food to those who cannot get to the drop off points in Central and South Broward.

I received an immediate response from Marcia Johansen of the Plantation GOP Club, so have asked her to speak with Club president Ken Nuelle to find a location quickly in Central Broward for May 30th, where food can be dropped off for pickup by people, and where we can deliver from to those who cannot get to that location.

Mary Sturm of the Davie/Cooper City GOP Club, who is always on board with our efforts, has alerted club president Jeff Rubinoff and his board, that we will need a location in the South for drop off, pickup and probable delivery.

- 3) Kinds of Food: We have asked that non-perishable items be brought to the food locations, and for delivery. Just a few of those suggested items can be canned vegetables, rice, spaghetti, noodles, tuna, dried and canned beans, peanut butter, jelly, cookies, oatmeal, tomato sauce, pancake and cake mix, et al. I received immediate responses from County GOP board member and state committeewoman Michele Merrell, who says that she has connections with produce carriers, and also received a response from Jana Gray-Williams, whose family founded the Broward Black Republican Club, who says that she also has connections with a food outlet that we can use. So, we will rely on them both for added assistance.
- 4) Food Delivery: We will have three locations in North, Central and South Broward for drop off and pick up, but we will also need to deliver food to those who cannot get to the designated drop off points. Clubs and Party members in those areas, knowing their local populace, should be able to tell us where families live that cannot get out to get the food. For example, in the North, we may have to deliver to the Collier City area, North Lauderdale, Margate, Coral Springs, and more; in the Central, we may have to deliver to Sunrise and

West Lauderdale; and in the South, we may have to deliver to sectors of Hollywood, Hallandale, and Miramar. We are going to count on leaders in those areas to let us know where specific deliveries should be made. For the delivery part of the effort, we estimate that we will need three U-Haul medium-sized rental trucks, for one-day usage in the three parts of the county, with more information regarding that to follow.



5) Volunteers: We are going to need volunteers to buy and bring food to the three locations that we designate during the days before Saturday, May 30, and we will need volunteers during the days leading up to that Saturday on site to bag food, and Rev. Dozier has taken on the responsibility to get us the plastic bags that we will need to bag food in. For the pass out and delivery, it has been suggested that our Republican candidates for the various offices in this election serve as volunteers to both pass out food and to deliver food. So, those candidates who have come to our clubs to ask for our support, can now . . . support the Party, and themselves, by volunteering to be on the front lines!!

6) *Publicity:* To get the word out about what we are going to do, we will need publicity, and . . . the timing has to be right. We want to get the word out "early enough" to alert those who need food to be ready for the May 30th Give Away. But, we want the publicity to be "close enough" to May 30th, so that the Democrats will not be able to martial their forces to counteract what we are going to do. Our publicity should include the both the *Sun-Sentinel* and *Miami Herald* newspapers (preferably the Sunday edition of May 24th, six days before the Give Away), while also including the three South Florida network TV stations, and local radio outlets as needed. I received a response from Broward County Republican Party Chairman George Moraitis, who said to let him know what the Board can do for this effort.

So, at this point, we are asking two things of the Party board: a) The publicity effort, with those the chairman designates to be responsible for getting the word out, in writing and through interviews, especially including board member and state committeeman Richard DeNapoli, who has shown a propensity in the past for getting us much needed publicity; and b) The money from the Party treasury to rent the U-Haul trucks, with the thinking being that there may be volunteers who may want to offer their trucks, but we do not want to run into "logistics and timing" issues trying to locate and schedule those private trucks, nor do we want to run into "liability" issues that may cost the Party financially in the long run.

I want to let George Moraitis and the entire board know, that if they do not want to put up the finances for the one-day truck rentals... I will go into my pocket to finance the effort myself, because I feel so strongly about what this food give

away, along with all our political efforts, can do to help us win in November!!

Well, there you have the up-to-the-minute update, and I await your responses, if any, to what I have said in the above message.

MAY 11 UPDATE: The Republican Party Food Give Away that is planned for Saturday, May 30th, now has a second drop off, pick up, and delivery location confirmed, as this event is beginning to take on . . . a life of its own!!

The initial thinking was that North, Central, and South Broward should be covered as locations for the Give Away, with Rev. O'Neal Dozier offering his Worldwide Christian Center church in Pompano Beach as the North location, and long-time GOP activist, and former Party Chairman Rico Petrocelli, speaking with Plantation mayor Lynn Stoner to alert her to our effort, with her referring him to Phil Goodrich, the city's Supervisor of Parks and Recreation, who confirmed our request for the use of Central Park in Plantation for the Give Away.

So, it is now "two down, with one location to go," as we move forward. With regard to that, Mary Sturm is now working very hard to get us a South location. Along with the three location sites where people can pick up food from 9 a.m. until 1 p.m. on May 30th, we also want to deliver food items, for people who cannot get to the sites, to areas around the North site into, for example, the Collier City subdivision of Pompano. When we finally get a South location, we will also want to deliver items into the Liberia community of Hollywood.

We may not get to everyone during this Food Give Away, but with the current response, and how it will help us politically, we may want to do it again at some point before the November election.

Now, for those who have stepped up to offer assistance, the following is just a random sample.

- 1) **Broward County GOP:** Executive Consultant Lauren Cooley contacted me to say that the County Republican Party will help us with publicity, by publicizing the event to all on their database, and with local media outlets. The Party also wants to be apprised of the cost for one-day truck rentals for food delivery, so that the Broward GOP can pay U-Haul directly, once the cost is approved by the Board. However, we may not need the Party to pay for truck rentals, as we have two people, so far, who have volunteered the use of their trucks for delivery. **Will more be offered?**
- 2) Volunteer Truck Usage: Grassroots organizer Nancy Dagostino, who works with Republican Party of Florida regional representative Lucdwin Luck, was referred to me by her fellow organizer Jeanne Kacpzak, and Nancy has volunteered the use of her family truck for that day. Also, a candidate for U.S. Congressional District 22, Jim Pruden volunteered the use of his truck. That's . . . two trucks down, and we wait for others to jump in with additional offers for trucks!
- 3) Candidates Who Have Stepped Up: I mentioned congressional candidate Jim Pruden offering the use of his truck for food deliveries on May 30th, but Jim even went a step further by offering \$500 worth of food for the cause. Catherine McBreen, candidate for Broward Supervisor of Elections, responded by saying that she will be available to pass out food

at one of the locations on May 30th, and I am sure she will also bring food. Lateresa Jones, who is a member of Rev. Dozier's church and a candidate in U.S. Congress District 20, called me to say, "I qualified for the ballot as a No Party Affiliation, because I had to pay the ballot qualification cost out of pocket, and NPA was \$4,000 cheaper. But, let the people know that I have always been, and will always be a Republican, and I will bring a lot of food for May 30th." Congress District 23 candidate Carla Spalding also responded to say Count Me In, so I expect her to bring food also.

Regarding other Republican candidates, who we have not heard from, and are running for election, especially on the August primary ballot, let me say this to them, and let me emphasize the wording for effect. Sharon Day, who is now our country's Ambassador to Costa Rica, who has been both a National and State Committeewoman, who brought the 2012 GOP Convention to Florida, and who was instrumental in Donald Trump winning the Party nomination at the 2016 Ohio GOP Convention, once told me this years ago when I asked her about a candidate trying to get Party support for an office that person was seeking: "We support those who help and support us." A member of several GOP Clubs, Sandy Friedland, has pledged to give \$100 to our effort from her family foundation, and Joe D'Uva, President of the Kings Point Republican Club, reported to me that many residents of that development will be bringing food items to one of our location sites when it is time. And, another person, who wanted to go nameless, has said that she will be bringing pounds of candy to one of our locations, to give away to families with youngsters, who are voters of the future. Other people, too numerous to mention, have said that they will also "be there" when the time comes.

So, there you have my update, as things are picking up at an "alarming rate," and we are three weeks out until May 30th. Although we will need volunteers beginning May 26th, the day after the Memorial Day Holiday, to begin bagging food items that last week at the various location sites, we will also need additional offers of trucks for delivery, and we still need a drop off, pick up, and delivery location in South Broward.

Looking at what people are doing, so far, I am . . . SO VERY PROUD TO BE A REPUBLICAN!!

A mericans are not a hateful people. In fact, we are more welcoming and tolerant of all peoples than any other country on earth. It is both our moral foundation and our strength.

Americanism is not based on ethnicity or race. It is based on a broadly held belief in a range of governing principles—most notably that all people are equal in our humanity and our inalienable rights. Once we find superiority in race, ethnicity, gender, religious beliefs or sexual orientation, we are no longer cultural Americans. We are no longer good Americans no matter how many times we chose to wave or burn the flag.

In a previous commentary, "America ain't racist." I noted that billions of times each day black and white citizens work, play and love in harmony with one another. The malignancy of racism exists in the hearts of very few Americans—even if those few create a false impression by garnering unbalanced attention.

Today, the Covid-19 virus has created an opportunity for the ignorant few to emerge from deserved obscurity to direct their venom against those of Asian ancestry—especially the Chinese. It is an abomination and a tragedy.

While it is true that Covid-19 rose out of the city of Wuhan in China—and that the Chinese government lied about the source and seriousness of the disease—resulting in an unnecessarily severe and deadly pandemic. That had nothing to do with the Chinese people—and even less to those we refer to as Chinese Americans.

It is not easy to understand what level of fear-based hatred motivates people to vent against individuals they do not know based on ethnicity. It is irrational. It was a Chinese American doctor who saved my life and restored my vitality. It was a Muslim cardiologist and an Indian American cardio-surgeon who teamed up to provide me with a liferestoring quintuple bypass more than 21 years ago—after a Caucasian doctor screwed up an angioplasty procedure.

Those who take the liberty to insult or assault Asians on the streets are the true UN-Americans. They may have descended in America for five generations, but they do not embrace Americanism. By their action, they show a contempt for American values as an immigration society. They ignore the contributions their targets make to America—arguably more beneficial than those who harbor racial and ethnic hatred.



While I see xenophobia and racism of all kinds as a marginal issue in America, that does not make it less dangerous. It provokes and ignites animosities that are better left hibernating under the rock. There will always be people motivated by racial hatred. They cannot be obliterated by laws. That only addresses institutionalized racism as we once saw in the old south and of which we still see the remnants in our major cities.

Personal racism recedes only in the face of education, socialization and the overt example of the good people. This is not a time to ostracize and target Asian Americans, but to defend them as fellow citizens under assault by the weak, the unenlightened and the social malcontents, who make false claims of being "good Americans."

As civil rights leader Whitney Young once noted, we only need a coalition of good against the coalition of evil. That is applicable today as much as ever.

On 1 March a press release from his office said "There is no reason for undue anxiety. The general risk remains low in New York. We are diligently managing this situation." It was not until March 20 that he ordered 100% closure of non-essential businesses statewide.

It is currently reported that there have been 19,415 deaths in New York State. That is almost 30% of the deaths nationwide.

On March 25 Coumo ordered that no resident shall be denied readmission or admission to a nursing home solely based on a confirmation or diagnosis of COVID-19. This was at a time when there were significant beds available aboard the hospital ship and the Javits Center. There are reports that this caused residents of nursing homes that had few cases to become infected

Two days ago it was reported that there were 1,700 new previously undisclosed deaths at nursing homes in New York.

The other day the Governor acknowledged and expressed his appreciation to the President for his responsiveness in making sure adequate ventilators and hospital beds were made available to his state.

Today even the usually loyal *New York Times* took Como to task. They reported that New York became the primary source of new infections spreading throughout the United States. New research revealed that thousands of infected people traveled from the city and precipitated outbreaks around the country. "We now have enough data to feel pretty confident that New York was the primary gateway for the rest of the country," said Nathan Grubsugh, an epidemiologist at the Yale School of Public Health. The article

said that during crucial weeks in March, New York political leaders waited to take aggressive action, even after identifying hundreds of cases, giving the virus a head start. It is estimated that infections spreading from New York account for 60 to 65% of the sequenced viruses across the country. Scientists agreed that New York prominence in seeding the national spread appears to have begun in early March, two weeks before stay-at-home orders were put in place by the Governor.

Book Review

Iran's Strategic Penetration of Latin America, edited by Joseph M. Humire and Ilan Berman. Lanham, MD: Lexington Books, 2014. Hardcover, 123 pp. ISBN No. 978-0-7391-8266-6.


Iran's Strategic Penetration of Latin America is edited by Joseph M. Humire and Ilan Berman, who along with a number of other distinguished authors produced this short but eye-opening look at what the Islamist clerics of Iran are up to in America's own back yard. Mr. Humire is the executive director for a Secure Free Society and Mr. Berman is vice president of the American Foreign Policy Council, and they dedicate their book "For those continuing to fight for freedom and security in Latin America and the Middle East."

It is often said that the United States does not pay enough attention to Latin America in its foreign policy, and if that be the case, the subject of this book is exhibit A. But perhaps our Latin American neighbors are also not following events as closely as they should. As Diego E. Arria, former president of the United Nations Security Council and presidential candidate in Venezuela, has said, "When the late Hugo Chavez proclaimed Venezuela's 'Axis of Unity' with Iran in July 2006, many Western intelligence agencies did not take him seriously. Eight years later, this union has enabled Iran's feared Revolutionary Guards and other military and intelligence assets to have a robust presence in the Western Hemisphere. Sadly, the majority of Latin Americans are still ignorant of this. . . . Hopefully this [book] will serve as a wake-up call to my fellow countryman."

Not everyone in our hemisphere needs to be briefed on this threat from Iran. According to Marta Lucia Ramirez, former National Defense and Foreign Trade Minister of Columbia, "Venezuela's outsized role in providing a gateway to Iran into the region, complete with arms deals, military transfers, and clandestine intelligence cooperation, are proof that times have indeed changed. The Bolivarian Republic's 'axis of unity' with Iran embodies Latin America's growing distance from its traditional ally, the United States. Countering the influence of non-traditional, extra-regional forces in Latin America requires U.S. engagement. This is not to distract from the many conflicts the United States is engaging in the

Middle East or elsewhere, but rather to remind our northern neighbors of the kind of disengagement in Latin America that led to a nuclear standoff in 1962 [Cuban Missile Crisis]."

The purpose of this book, says Mr. Humire, . . . is to reveal what Iran does not want the world to know: that it views Latin America as a latent theater of operation, and that it is building its capacity and capability throughout the Americas.



One thing in the book that was particularly interesting to me was related by journalist Amir Taheri. According to Mr. Taheri, when the Ayatollah Ruhollah Khomeini came to power in the 1979 Iranian Revolution, it produced an ideological shift from Marxist to Khomeinist revolutionary thinking in the country. "The members of the Soviet-created Communists of The Tudeh (masses) Party replaced their portraits of Marx and Lenin with those of Ali Ibn Abi-Talib and Hussein Ibn Ali, the first and third Imams of Shiism. Their chief ideologist, Ihsan Tabari, even wrote a book to prove that Ali had been the true founder of "Socialism."

Two decades later, the Iranian regime invited the children of Ernesto "Che" Guevara to Tehran to attend a conference designed to showcase "the common goals" of Islamist radicals and the Socialist left.

So it is no coincidence that Iran seeks to penetrate Latin America by using socialist Venezuela as its entry point. Their partnership with and affinity for the radical left goes back to the very beginnings of Ayatollah Khomeini's Islamist revolution. He advised Iran to get closer to the Soviet Union after he was gone, and in 1981 Communist Cuba became the first country to recognize the Islamic Republic.

This is a most informative book about a threat to all freedom-loving peoples of the Americas, and deserves a wide audience throughout the Hemisphere.
